


**APPLICATION SEEKING EARLY HEARING OF THE**  
**CONTEMPT PETITION NO. 100/386/2019 IN OA NO.**  
**2045/2016**

Most respectfully sheweth,

1. That this Misc. Application for Early Hearing is filed on behalf of the Applicant Forum, who are aggrieved by the non-compliance of this Hon'ble Tribunal Order dated 10.07.2017 in OA No. 2045/2016 and in the context of submissions made by the Counsel for the Contemnors in regard to OM No. 4/4/2011-SCS/Vol.III/7809 dated 13.06.2017 before this Hon'ble Tribunal whereby it was stated that substantial part of the relief prayed for stands granted on the issue of two additional increments.




2. That the Counsel for the Forum contended that despite the fact that the High Courts of Kerala and Uttarakhand have already allowed the claims and the judgments have attained finality with the dismissal of the SLP filed in the Hon'ble Supreme Court.
3. That this Hon'ble Court has allowed the reliefs sought by the applicants with a direction to the Respondents to release the amounts in terms of Para 3 of the Department of Atomic Energy OM dated 13.06.2017, within a period of three months vide Order dated 10.07.2017. A true and correct copy of the Order dated 10.07.2017 is annexed and marked as **Annexure MA-1**.
4. That initially Department of Atomic Energy started implementing the OM in a few cases and then the process of implementation stopped all on a sudden. After waiting for about a year, waiting for the implementation of the OM for others, a contempt petition was filed as there was no other alternative.
5. That after filing of Contempt Petition on 30.07.2019 and Notice issued thereon, the contemnors took almost two years and are yet to file their reply in the above said Contempt Petition. Even after listing the matter for several times, the case could not reach for hearing as there have been *enbloc* adjournment of the cases due to COVID-19 pandemic.






6. That the applicants, the members of the Forum are aggrieved due to the non-listing of the Contempt Petition for more than two years. Moreover, it is an admitted fact that since the filing of the OA in 2016, the members of the petitioner Association are waiting to get the required relief. It is not out of place to mention that similar OMs issued by the Department of Space, DRDO etc. have been implemented fully and the Scientists working there in have got all the benefits. Thus the applicants who are similarly placed are treated differently for no plausible reasons.
7. That in the meanwhile some of the members of the Forum have passed away; some of the members aged above seventy or seventy five years are expecting to see the colour of the coin during their lifetime itself. Moreover the delay has caused frustration and disappointment among the members of the Applicant Forum.
8. That in view of the above practical difficulties and anguish of the members facing a differential and step motherly treatment in the implementation of the Order granting two additional increments, the applicants are constrained to file the present MA for early hearing of the Contempt Petition No. 386/2019.





**PRAYER**

In the light of the above facts and circumstances of the present case, it is humbly prayed that this Hon'ble Tribunal may graciously be pleased to allow the present Misc. Application and direct the Registry to list the case of the applicants for early hearing.






